If tank mixing, add components in this order: Water, Ag chemical, Nexus Liquid Copper 5%. **MIXING:** Shake, stir, or swirl contents before using. Always add this product to the spray tank before adding pesticides. **FOLIAR APPLICATIONS FOR ALL CROPS:** Apply 5-10 L/Ha (2-4 liters/acre) as needed on a 7-14 day schedule. **Avoid** foliar applications of this product when plants are under moisture stress. **Avoid** foliar applications to deciduous tree crops during bloom. **Concentrate Applications:** Use up to 1 liter of NEXUS LIQUID COPPER 5% in a minimum of 100 liters of water per acre. **Aerial Applications:** Up to 1 liter of NEXUS LIQUID COPPER 5% per 4 liters of spray may be used, but more dilute solutions will improve coverage and results.
