**COMPATIBILITY:** NEXUS LIQUID MANGANESE 7.5% is compatible with most pesticides and fertilizers. However, if the desired combination has not been previously used, a compatibility test is recommended. Add appropriate portions of the materials that you are going to mix, agitate and observe that they are compatible before proceeding. If tank mixing, add components in this order: Water, chemical, Nexus Liquid Manganese 7.5%. **MIXING:** Shake, stir, or swirl contents before using. Always add this product to the spray tank before adding pesticides. **FOLIAR APPLICATION FOR ALL CROPS:** Apply 5L/Ha (2 liters/acre) as needed on a 7-14 day schedule. Avoid foliar applications of this product when plants are under moisture stress. Avoid foliar applications to deciduous tree crops during bloom. Product should be used based on soil or tissue analysis. Seek advice of an agricultural consultant.

**Concentrate Applications:** Use up to 2.5 liters of NEXUS LIQUID MANGANESE 7.5% in a minimum of 250 liters of water per hectare (1 liter/100 liters per acre). **Aerial Applications:** Up to 2.5 liters of NEXUS LIQUID MANGANESE 7.5% per 10 liters of spray per hectare (1 liter per 4 liters per acre) may be used, but more dilute solutions will improve coverage and results.
