Soil applications may be made by drip, sprinkler or furrow irrigation systems or in band or broadcast fertilizer applications. **COMPATIBILITY:** NEXUS MANGANESE 5% EDTA is compatible with most pesticides and fertilizers. However, if the desired combination has not been previously used, a compatibility test is recommended. Add appropriate portions of the materials that you are going to mix, agitate and observe that they are compatible before proceeding. If tank mixing, add components in this order: Water, Ag chemical, Nexus Manganese 5% EDTA. **MIXING:** Shake, stir, or swirl contents before using. Always add this product to the spray tank before adding pesticides. **SOIL APPLICATIONS FOR ALL CROPS:** Rates: Product should be applied at rates from 2.5 to 5 liters/hectare (1 to 2 liters/acre). **FERTIGATION:** Apply the recommended amount of product in split applications one to two weeks apart throughout the growing season.
