Soil applications may be made through irrigation systems or in band or broadcast fertilizer applications. **COMPATIBILITY:** NEXUS ZINC 9% EDTA is compatible with most pesticides and fertilizers. However, if the desired combination has not been previously used, a compatibility test is recommended. If tank mixing, add components in this order: Water, Ag chemical, Nexus Zinc 9% EDTA. **MIXING:** Shake, stir, or swirl contents before using. Always add this product to the spray tank before adding pesticides. **SOIL APPLICATIONS FOR ALL CROPS: Rates:** Product should be applied at rates from 2.5 to 5 liters/ hectare (1 to 2 liters/acre). **FERTIGATION:** Apply the recommended amount of product in split applications one to two weeks apart throughout the growing season.
