Applicable Crops

Row crops (grains, legumes, flax, quinoa and forage), tubers, bulbs, and vegetables.

Application rate - row crops

- Planter box (dry): 120 g/ha
- In-furrow (dry, drip or spray): 200 g/ha

Application rate - tubers, bulbs & vegetables

- In-furrow (dry, drip or spray): 300 g/ha

Application Method

Seed treatment: Mix dry Rootella F™ powder directly and uniformly on seeds in the seed hopper or drill box, or in the bottom of the grain auger while filling the drill. Ensure uniform seed coverage and calibrate equipment.

In-furrow treatment: Rootella F™ may also be applied in-furrow, preferably under the seeds, either dry or wet (mix in water and use the same day).
